From the Pastor's Pen

As the pastor of a congregation with a variety of political opinions and having had conversations with a few of you about this I find myself praying for wisdom – a lot. As one who believes in the separation of church and state, weekly I prayerful craft sermons to speak to the readings and moral guidance that the scriptures offer us each Sunday. I do not venture into politics.

Also, as a student of history, I know the United States was not founded as a "Christian Nation," contrary to much of what I am reading and hearing in the news right now. However, the Founders did expect religious groups to inform the moral fiber of the electorate.

I feel a powerful moral compunction to speak out right now!

Separation of Church and State means the Church will not endorse candidates nor craft its message of the gospel in a way to forward one political party. Separation of Church and State also means that the State may not interfere with the Church.

Many of you know this already but allow me to share the opening segment from the website of the Reynold Law Group in a response to what a clergy person might say or not say from the pulpit.

"In 1954, Congress amended IRS Code § 501(c)(3) to restrict the speech of non-profit, tax-exempt entities—including churches. Before the amendment, there were no restrictions on church speech concerning government or voting, . . .

After the amendment, churches faced a choice: speak freely on all issues addressed by Scripture and potentially risk their tax exemption or remain silent and protect their tax exemption. . . . Ironically, after 60-plus years of strict interpretation by the IRS, there is no reported situation to date where a church lost its tax-exempt status or was punished for sermons delivered from the pulpit. Nonetheless, the law remains unchanged.

Recently, President Donald Trump signed an executive order relaxing the enforcement of the Johnson Amendment. Nonetheless, the amendment is still the law of the land because an executive order does not reverse legislation. Legislation can only be fixed by other legislation or by being ruled unconstitutional by the appropriate court."

You may or may not be aware of the viral X (Twitter) post from last week. Elon Musk said DOGE would shut down "illegal payments" to Lutheran charitable organizations as they were "laundering funds" for illegal purposes! Mr. Musk may not be aware – religious non-profits expanded mightily under the Reagan administration, as that administration sought to move programs *into religious charities* as they were seen as being less costly, more efficient than government run operations. Most religious charities had a core of committed volunteers who worked for little or no money and could run programs at much less cost to the federal government. Many religious organizations had space largely unused during the week, again a cost savings.

Since caring for the sick, poor, marginalized – the widow, the orphan, the alien – aligns with the Gospel, Christians responded to this call.

As someone long familiar with, and committed to, Lutheran Child and Family Services (LCFS) of Illinois I cannot begin to express the wound this post has caused!!!

LCFS does legal immigrant resettlement, counsels families in crisis, created a nationally copied model to assist the formerly incarcerated that dramatically reduced recidivism, actively sought to combat racism in the foster care system, oversees a foster care and adoption service that is one of the largest in Illinois, and many other good works. The state would leave young people who aged out of the foster care system to their own devices. LCFS created a program to find housing and job training for these vulnerable young adults. Shall I go on?

To accuse and threaten all our charities and to single out the work of Lutheran related organizations is, to me, the epitome of "Fake News," not to mention the slander and disrespect to thousands of our fellow Lutherans and partners of many beliefs who work with us to live out what we believe and make lives better. It ignores the true need and the hurt of those served.

Dear Church, I do not know how to call this administration and it's unethical and unaccountable wrecking ball tactics to account, except to speak out.


11:30 a.m. Adult Forum in the Chapel
